I advised him that I got a complaint about his burn pile and asked him if I could see where he was burning. I was escorted to his burn pile that was already extinguished. The pile was well over 75' away from any dwelling and more that 20' away from the property line. While inspecting the burn pile the owner from 2386 Pleasant St approached the area and started to yell and scream at the owner of 2396. I advised 2386 that his pile was within the burning regulations ab that I was contacting dispatch to send a police officer to 2396 Pleasant St due to his agitated state. PD arrived I explained the issue and the owner of 2396 Pleasant St was advised on their harrassment rights and then PD went to speak to 2386.
